The Office of Textiles and Apparel reported today that imports of cotton, wool, man-made fiber, silk blends, and non-cotton vegetable fiber textile and apparel products totaled 8,568.3 million square meter equivalents (MSME) in June 2025. Imports of textiles were 6,527.8 MSME in June 2025, up 3.1 percent from June 2024. Imports of apparel were 2,036.0 MSME in June 2025, up 0.5 percent from June 2024.

Imports of textiles and apparel were 49,455.6 MSME for the year-to-date June 2025, an increase of 6.9 percent from year-to-date June 2024. Imports of textiles were 37,304.4 MSME for the year-to-date June 2025, an increase of 6.4 percent from the year-to-date June 2024. Apparel imports for the year-to-date June 2025 were 12,184.3 SME, up 4.3 percent from the year-to-date June 2024.
