**February 3rd MEETING MINUTES**

**Welcome and Committee Business**

Designated Federal Officer (DFO) Megan Hyndman and ETTAC Chair Clare Schulzki welcomed committee members and began the meeting. The meeting minutes from the ETTAC December 9<sup>th</sup> meeting were approved.

**Subcommittee Readouts**

ETTAC subcommittees provided readouts of their recent subcommittee meetings and discussed priority topics and key areas of focus for future recommendation letters.

**Briefing: U.S. Government Export Finance Tools & Resources**

Jay Koh, co-chair of the Export Competitiveness and National Security Subcommittee, provided an overview of the ETTAC's July 2025 *Recommendation on Bundling Export Financing with U.S. Environmental Technology Offerings to Increase American Competitiveness* letter to the guest speakers, Foreign Commercial Officer Eli Lovely of the Department of Commerce's Advocacy Center and Deputy Director Andrew Clark of the Department of State's Office of Environmental Quality.

Mr. Clark briefed the ETTAC on how the Department of State works closely with other U.S. Government financing agencies, including the Export-Import Bank of the U.S. (EXIM), U.S. Trade and Development Agency (USTDA), Millennium Challenge Corporation (MCC), and International Development Finance Corporation (DFC). Additionally, Mr. Clark stressed how the Department of State coordinates with these federal agencies to review projects at Multilateral Development Banks to ensure they are aligned with U.S. policies.

Mr. Lovely explained how the Advocacy Center's government-to-government engagement supports U.S. exporters bidding on foreign government tenders. Additionally, Mr. Lovely provided an overview of the Advocacy Center's new Strategic Transactions Advocacy Track (STAT) program to counter foreign adversaries and promote U.S. solutions with foreign governments. STAT supports U.S. companies pursuing overseas investments of strategic value and enables the Advocacy Center to coordinate on projects that shore up supply chains and contribute to the U.S. industrial base.

**Mid-Charter Survey Results & ITA Updates**

Evelina Scott, Secondary Designated Federal Officer, provided a readout of the ETTAC mid-charter survey results. Secondary DFO Scott presented an analysis of the results and provided insight into the response data. An open discussion on the survey results followed, and ETTAC

members provided additional feedback and recommendations on how to shape the future of the Committee.

Global Environmental Technologies Team Leader Frances Selema briefed the ETTAC on current trade leads and events, emphasizing opportunities for environmental technologies companies to participate in Commercial Service-led matchmaking events at World Mining Congress 2026, which will be taking place in Peru in June. Additionally, Ms. Selema previewed a March 19th webinar highlighting opportunities in the water infrastructure sector in Brazil. Finally, Ms. Selema reminded the ETTAC to consider [signing up for ITA's monthly environmental technologies industry newsletter](#).

### **Working Lunch & Closed Session Subcommittee Meetings**

ETTAC members broke out into their respective subcommittees and discussed their priorities and areas of engagement.

### **Draft Recommendation Discussion & Approval**

The committee deliberated on one draft recommendation letter. The Export Competitiveness and National Security Subcommittee presented on the draft *Recommendations from the ETTAC on Supporting U.S. Manufacturers of Recycled Plastic*, which urges the Department of Commerce to investigate and address unfair trade practices, including potential dumping of dubious recycled materials. The committee reviewed the letter, made final edits, and then approved the letter as drafted.

### **Next Steps, Public Comment**

DFO Hyndman and Chair Schulzki discussed next steps leading up to the next full ETTAC meeting on April 28<sup>th</sup> and encouraged subcommittees to meet in March. They flagged that an ad-hoc virtual ETTAC meeting will be tentatively held on June 16<sup>th</sup> to deliberate recommendation letters. Finally, DFO Hyndman urged ETTAC members to submit all new briefing requests by February 16<sup>th</sup>.

There were no public comments.

### **Briefing: Open Data Policy**

Dominique Duval-Diop, Chief Data Officer, Department of Commerce and Tony LaVoi, Chief Data Officer, NOAA, [briefed the ETTAC on the Department of Commerce and NOAA's open data policy framework](#).

Ms. Duval-Diop provided opening remarks on the Department of Commerce's data resources and its approach to open data. Mr. LaVoi discussed NOAA's Open Data and Policy Framework, describing how NOAA collects and utilizes data and makes it available to a wide array of users and the public. He stressed that NOAA's data is open by default, with only a very small percentage of data unavailable to the public. He emphasized the importance of open licenses to maximize the value of data. He also summarized the main legal statutes relevant to open data and provided some examples of NOAA's data dissemination platforms. Finally, Mr. LaVoi discussed the current challenges and opportunities for data sharing and highlighted how NOAA partners frequently with private industry to supplement government data.

The meeting was adjourned at 3:14 p.m.
